WHEREAS, the Goldendale Police Department has certain personal property that is no longer necessary and appropriate for use by such department, and

WHEREAS, the Goldendale Public Works Department has determined that the fair market value is less than \$2,000, and

WHEREAS, said personal property can be used by other public agencies within Klickitat County, Washington, and

WHEREAS, the Klickitat County Sheriff's Office has agreed to accept the surplus 1995 Ford Pickup, animal control vehicle, in its "as is" condition and without any warranty, expressed or implied, and

WHEREAS, the Klickitat County Sheriff's Office has agreed to transfer five (5) light bars, in exchange for the 1995 Ford Pickup,

NOW, THEREFORE BE IT RESOLVED by the City Council as follows:
